

19° EDITION " INTERNATIONAL SHORT FILM FESTIVAL MALESCORTO"

31 July - 4 AUGUST 2018 REGULATION

Organizers

The municipality of Malesco and the Ecomuseum And Leuzerie and Scherpelit will organise - by 31 July to 4 August 2018 - the 19th Edition of the international short films Festival "MALESCORTO" with the support of Regione Piemonte, Val Grande National Park, Ordine degli Architetti, Pianificatori, Paesaggisti e Conservatori of Novara and VCO, Associazione Musei dell'Ossola and Centro Servizi per il Territorio Novara-Vco (Center Services for Novara and VCO).

Participants

Participation in the competition is open to all without distinction of nationality or residence. Directors, production companies and educational institutions are eligible for participation.

In the case of participants under the age of 18, it will be necessary to prove the consent of a parent or legal guardian.

Requirements and conditions

There is no participation fee.

Incomplete or illegible materials will not be taken into consideration.

Works in foreign language must be subtitled in Italian. In case subtitles in Italian are not available, subtitles in srt format in one of the following languages: English, French, Spanish must be provided (separately from the video file). In case of missing subtitles, the work may be excluded from participation.

In case the works will not be judged of acceptable quality, no prize will be awarded.

Short films' Duration

Short films must not be longer than 20 minutes. Short films made by schools (section Maleskids) must not be longer than 10 minutes.

Submission

For the preselection, the works must be submitted by mail, in DVD format, accompanied by the Participant Entry Form and a presentation of the author and of the work, with photographs and news related to its realization. DVDs must be labeled (also on the case), indicating: title, Director, contacts.

The works may also be reported through popular video platforms (i.e. vimeo, youtube, etc.) or through on-line file sharing services (i.e. wetransfer, dropbox, etc.) or private ftp. If you choose one of methods above, paper documents relating to the submitted works (including the Participant Enrty Form) must be sent by mail.

Schools willing to submit must fill out the specific form and attach the school permission to award a person other than the school.

Deadline for submissions

The works submitted for the selection must be sent by 30 April 2018, as shown by the postmark.

Selection communication

The authors of the works selected for the Festival will be notified by email from the direction of the Festival.

Selection and jury

The short films will be examined by a jury composed of a minimum of three and a maximum of five people chosen by the Festival's artistic director, Paolo Ramoni.

Awards

First Prize:

• Prize "MALESCORTO" 2018 (€1000.-), assigned to the best short film director.

Special Awards

- Prize "animated films" 2018 (€200), assigned to the production company for best animation short film. This award is offered by the Association Museums of Ossola.
- Prize "MALESKIDS" 2018 (€300), assigned to the school and to the production for the best short film made by schools.
- 2018 PRIZE "CINEMA AND ECOLOGY" (€300), assigned to the Director of the best short film inspired by ecological issues. This award, created in collaboration with the National Park of Val Grande, will reward the shorts that will describe the relationship between man and nature from an ecological perspective, or the relationship between man and nature. There is no restriction on geographical area.
 - Within this section, it may also be awarded the Exclusive Mention "Free and Wild" 2018 (with the corresponding special award of €200.-); this mention will be given to the best short film shot within protected areas, parks and geo-parks.
- Prize "BROADCASTARCHITECTURE" 2018 (€400), assigned to the production company of the short film set in the best indoor or outdoor location. This award is offered by the Ordine degli Architetti delle Province di Novara e VCO.
- Prizes "VOLUNTEERING AND SOLIDARITY" 2018 (special classification section with the following prizes: €300.-first prize, €200.- second prize, €100.- third prize), awarded to the best short film inspired by the theme "volunteering and solidarity." Prizes will not be awarded cash, but in services from CST Center Services for Novara and VCO (quantified on the basis of the cash value of the prize itself) and will be assigned exclusively to voluntary associations of Novara and VCO (and credited to CST); entries can be submitted both by voluntary associations (as producers) and by individuals involved in the production that will have to allocate the prize to an associations of their choice that meets the above requirements. These prizes will be assigned to voluntary associations only.

Special mentions:

- BEST SHORT DOCUMENTARY 2018
- BEST SHORT FICTION 2018
- AUDIENCE AWARD 2018
- BEST SHORT FILM FROM THE VCO

Final provisions

- The works sent will not be returned.
- The direction of the Festival is not responsible for any theft, damage or loss of material.
- The works that meets the requirements above will be catalogued and become part of the Festival's archive. The archive will remain available on request to schools and institutions for educational purposes only. Short films may be used for non-profit promotion events supported by Ecomuseum And Leuzerie and Scherpelit, by the municipality of Malesco, by Val Grande Park and Val Grande del Sesia Geopark for the section "Free and Wild"; by Ossola Museums Association for animated shorts; by the CST for the section "volunteering and solidarity"; by Ordine degli architetti Novara e VCO for section BroadcastArchitecture; the works of this last section will become part of the archives of Ordine degli architetti Pianificatori, Paesaggisti e Conservatori delle of Novare and VCO for non-profit use only.
- The projections to the public, will be performed at the Cinema Comunale of Malesco (VB). The selected short films will be screened from 31 July to 3 August 2018 at 21.00; the awards ceremony will take place Saturday 4 August 2018 at 21.00, followed by the screening of the winning short films.
